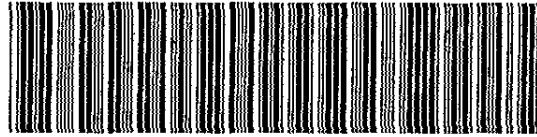

ARTICLES OF INCORPORATION

OF

A & D PROPERTY MANAGEMENT & MAINTENANCE, INC.

THE UNDERSIGNED, who desires to form a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME
