ARTICLE I - NAME AND ADDRESS

The name of this corporation is Baker Cummins Dermatologicals, Inc. The address of the principal office and the mailing address of this corporation is 4400 Biscayne Boulevard, Miami, Florida 33137.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which this corporation shall have authority to issue is One Thousand (1,000) shares of common stock, all of which are to have a par value of One Cent (\$0.01) per share.
