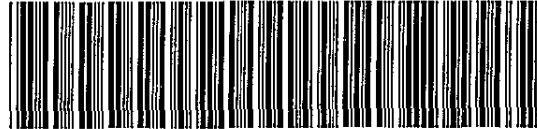

ARTICLES OF INCORPORATION DONNIE GODWIN DRYWALL, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE

The corporate name is, **DONNIE GODWIN DRYWALL, INC.**

ARTICLE TWO


ARTICLE FOUR

ARTICLE SIX

The general purposes for which the corporation is organized are:

2. The power to make, alter, amend and repeal the bylaws of the corporation shall be reserved to the stockholders.

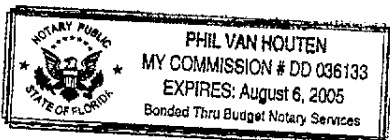
The stockholders shall have the right to determine in every instance the consideration for which shares of the corporation shall be issued.
