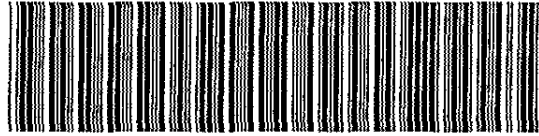

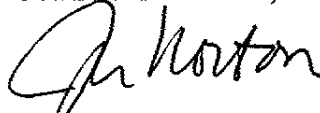

ARTICLE I  
NAME

The name of the professional corporation is Linda W. Hargreaves, P.A.

ARTICLE II  
DURATION

The duration of the corporation is perpetual. The date and time of commencement of the corporate existence shall be the date and time of the filing of these Articles of Incorporation by the Department of State of the state of Florida.

ARTICLE III  
PURPOSE

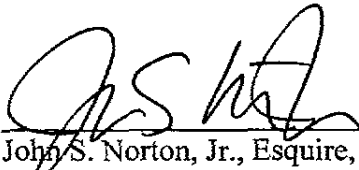
