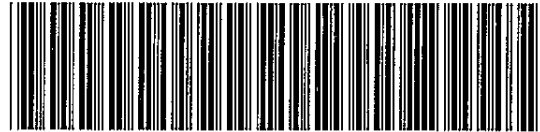

The name of this corporation shall be:

FIRE CONTROL HYDRANT MAINTENANCE, INC.

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

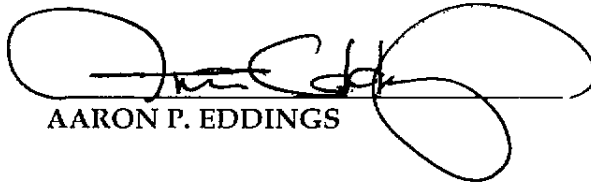

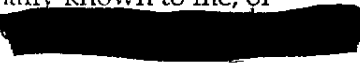
