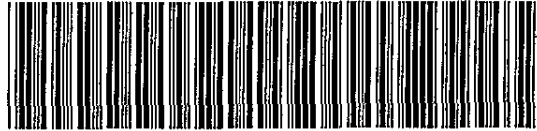

THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation for profit under the laws of the State of Florida, in compliance with Chapter 607 and/or Chapter 621, Florida Statutes, and further does agree to the following conditions of said corporation:

ARTICLE I: NAME

The name of the corporation is:
