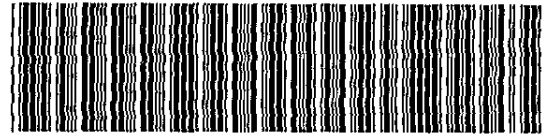



These Articles of Dissolution are being filed in accordance with Florida Statutes §607.01 and to effectuate the wind up and liquidation of all business associated with the existence of Chorak Insurance, Inc.

1. The name of the corporation is Chorak Insurance, Inc. (hereinafter the "Corporation").
2. The date of issuance of the Corporation's Articles of Incorporation is February 2, 2004.
3. No shares of stock of the corporation were issued and sole control of the Corporation was vested in Richard B. Chorak as President/Director/Sole Incorporator.
4. No debt of the corporation remains unpaid.
5. The purpose of these Articles of Dissolution is to finalize all of the business affairs of the Corporation and to effectuate its liquidation.
