ARTICLE I – NAME

The name of this corporation is FM DEVELOPMENT CONSULTANTS, INC. located at 1682 Hibiscus Blvd., Melbourne, FL 32901.

ARTICLE II – DURATION

This corporation shall have a perpetual existence commencing upon the date of subscription and knowledge hereof as provided by Florida Statute 607.0203.

ARTICLE III – PURPOSE

The nature of the business or purposes to be conducted or promoted are: To manufacture, design, construct, own, use, buy, sell, lease, hire, and deal in and with articles and property of all kinds and to render services of all kinds, and to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida.

ARTICLE XIII – AMENDMENT




