FILED 2004 JAN 29 P 5: 18 The undersigned incorporator, for the purpose corporation under the Florida Business Corporation Act adopts the following Articles of Incorporation.

ARTICLE I

NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION

AKAS ENTERPRISES OF ORLANDO INC. The name of the Corporation is principal place of business of the Corporation 726 LAKE WORTH CIRCLE, HEATHROW, FL 32746. The duration of the Corporation is perpetual.

ARTICLE II

REGISTERED OFFICE AND AGENT

The address of the registered office in the state of Florida is 726 LAKE WORTH CIRCLE the city of HEATHROW in the County of SEMINOLE. The name of the registered agent at such address is HIMANSHU THAKKAR.

The Board of Directors may distribute in kind to the holders of Common Stock such remaining assets of the Corporation or may sell transfer or otherwise dispose of all or any part of such remaining assets to any other Corporation, trust or other entity and receive payment therefor in cash, stock or obligations of such other Corporation, trust or other entity, or any combination thereof, and may sell all or any part of the consideration so received and distribute any balance thereof in kind to holders of Common Stock. The merger or consolidation of the Corporation into or with any other Corporation, or the merger of any other Corporation into it, or any purchase or redemption of shares of stock of the Corporation of any class, shall not be deemed to be a dissolution, liquidation or winding up of the Corporation for the purpose of this paragraph.
