The undersigned, VICKI DEASON, does hereby make, subscribe, acknowledge and files these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation shall be DEASON - O'NEAL, INC.

ARTICLE II

NATURE OF BUSINESS

The corporation is organized for the purpose of general construction and any other legal purposes, with its principal place of business at 34330 Umbrella Rock Road, Webster, FL 33597, and mailing address shall be the same.

ARTICLE III

CAPITAL STOCK

The capital stock of this corporation shall consist of One Hundred (100) shares of common stock with par value of One Dollar (\$1.00).
