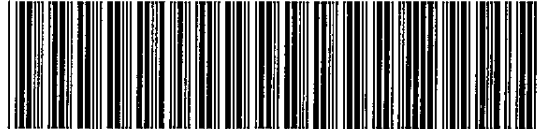

The name and address of this corporation is: GRAFFITI EMB, Inc., 6851 West Sunrise Blvd., Suite 100, Plantation, Florida 33313.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

ARTICLE III - PURPOSE

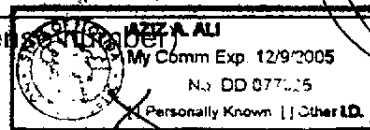
