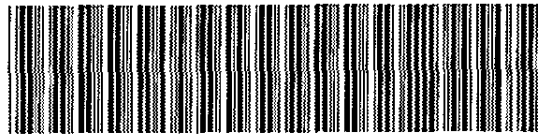

**CERTIFICATE OF INCORPORATION


