ARTICLES OF INCORPORATION OF

AQUA FLOW IRRIGATION, INC.

LAHASSEE, FLORIDA JAN 30 AM 7: 150

The undersigned, for the purpose of forming a corporation under the provisions of the FLORIDA GENERAL CORPORATION ACT, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is AQUA FLOW IRRIGATION, INC.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The corporation will engage in the operation of a company dedicated to the sales, installation and maintenance of irrigation systems or any other business activity authorized under the laws of the State of FLORIDA or of the laws of the United States.

ARTICLE IV

The Corporation shall have authority to issue one (1) class of Capital Stock which shall consist of five thousand (5,000) shares of one dollar (\$1.00) PAR value Common Stock.
