ARTICLES OF INCORPORATION OF VALENTINE TILE, INC.

ARTICLE I - NAME

The name of this corporation is VALENTINE TILE, INC.. The principal place of business of this corporation shall be 15108 NW 25th Terrace, Gainesville, Florida, 32609.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
