**ARTICLES OF DISSOLUTION

Pursuant to the provisions of Section 607.1403 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Dissolution for the purposes of dissolving the corporation:

1. The name of the corporation filing these Articles of Dissolution is ALL WOMEN'S HEALTHCARE OF PEMBROKE PINES, INC., a Florida corporation (the "Corporation"). The Articles of Incorporation of the Corporation were filed on February 5, 2004 under Document No. P04000025089.
