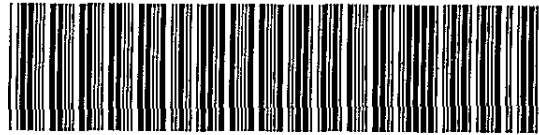

I, the undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be **H. J. DRAJEM CONSTRUCTION, INC.**

ARTICLE II - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III - DURATION

The duration of this corporation shall and will be perpetual unless sooner dissolved by law.

ARTICLE IV - PRINCIPAL OFFICE AND REGISTERED AGENT

The principal place of business of the initial registered office of this corporation and its mailing address shall be 12117 Garden Lake Circle, Odessa, FL 33556, and its initial registered agent shall be H. J. Drajem, 12117 Garden Lake Circle, Odessa, FL 33556.

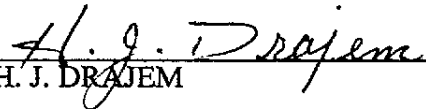
