ARTICLES OF INCORPORATION

These Articles of Incorporation are adopted for the purpose of forming a corporation and laws of the State of Florida, to be filed with the Florida Department of State, as follows:

ARTICLE ONE: NAME

The name of the corporation is Mark Nyland Painting, Inc., and the address of its principal of its 4875 48th Ave W, No. 1016, Bradenton, FL 34210, until and unless such address is subsequently changed by the corporation.

ARTICLE TWO: COMMENCEMENT AND DURATION
