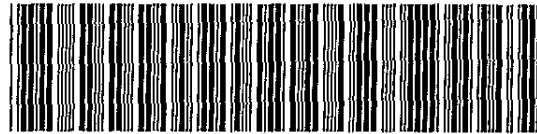

The undersigned, for the purpose of forming a corporation under the Florida General Corporations Act, hereby adopts the following Article of Incorporation.

ARTICLE ONE

The Corporate name is:

PRINCIPLE OFFICE

DURATION
