The name of this corporation shall be Southern Comfort Kitchens Inc. and the initial address of this corporation shall be 655 Gladiola Street Merritt Island, Fla 32952

ARTICLE II

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory, or nation.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

This corporation shall indemnify and insure its officers and directors to the fullest extent permitted by law either now or hereafter.

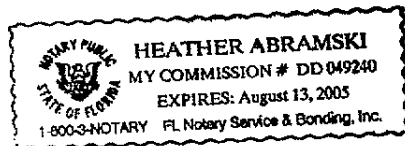
