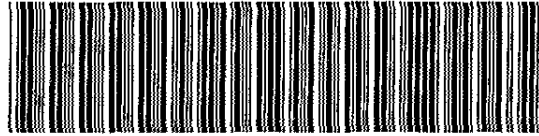

ARTICLES OF INCORPORATION

OF

S&S CARPETING, INC

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be S&S Carpeting, Inc.

**ARTICLE II
Principal place of business and mailing address**

The principal place of business of this corporation shall be 1301 Cypress Street, Live Oak, FL. 32064 and mailing address shall be 1301 Cypress Street, Live Oak, FL 32064. The Board of Directors may from time to time move the Principal Office to any other address in Florida.

**ARTICLE III
