

ARTICLES OF INCORPORATION

OF

GAIL'S BAIT PAIL, INC.

The undersigned, for the purpose of forming a corporation under the Blor Corporation Act, does hereby adopt the following Articles of Incorporation:



ARTICLE I

The name of this Corporation is: GAIL'S BAIT PAIL, INC.

ARTICLE II

The duration of the Corporation is perpetual.

ARTICLE III

The general purposes for which the Corporation is organized are: To operate any legal business not subject to regulation by federal, state or local government, entity or agency.
