## ARTICLES OF INCORPORATION

OF

### THE ESTIMATING ROOM INC.

I, the undersigned, being of legal age and a natural person, do hereby subscribe to acknowledge and file the following Articles of Incorporation for creating a corporation under the laws of the State of Florida.

#### ARTICLE I

The name of this corporation shall be **THE ESTIMATING ROOM INC.**, initial address of this corporation shall be 1900 Mears Parkway, Margate FL 33063

#### ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of FLORIDA.

#### ARTICLE III

Number of Shares	Par Value	Class of

100,000	\$ 1.00	Common

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of the corporation.

#### ARTICLE IV

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

#### ARTICLE V

The initial registered office of this corporation shall be at 1900 Mears Parkway, Margate FL 33063 with the privilege of having its offices and branch offices at other places within or without

the State of Florida. The initial registered agent at that address shall be MICHAEL SAMMARITANO

#### ARTICLE VI

This corporation shall have at least 1 directors initially, with the exact number to be specified by the stockholders from time to time unless the stockholders shall, by a majority vote thereof, determine that the corporation be managed by the stockholders.

No contract or other transaction between this corporation and any other corporation, and no act of this corporation, shall in any way be affected or invalidated by the fact that any of the directors of this corporation are pecuniary or otherwise interested in, or are directors or officers of, such other corporation. Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniary or otherwise interested in, any contract or transaction of this corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any director that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any director of this corporation who is also a director or an officer of such other corporation, or who is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation which shall authorize any such contract or transaction, with like force and effect as if he were not such a director or officer of such other corporation, or not so interested.


ARTICLE X




