ARTICLES OF INCORPORATION

OF

PEEBLES & MORIARTY, P.A.

The undersigned Incorporator, for the purpose of forming a profit Corporation pursuant to Florida Statutes, Chapter 621, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the Corporation shall be PEEBLES & MORIARTY, P.A.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be: 1111 - 3rd Avenue West, Suite 210, Bradenton, Florida 34205.

ARTICLE III. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted and carried on by the Corporation is to engage in the practice of the legal profession and any lawful act and activity or business permitted under the laws of the United States and the State of Florida. This corporation is organized for the following purposes:

- a. To engage in the practice of law as a professional law corporation and to carry on services incident to the practice of law The practice of law is the sole and exclusive professional service to be rendered by this corporation.
- b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been admitted to the bar of, and is duly authorized to practice law in, the State of Florida.

ARTICLE IV. SHARES

The number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1000, with a par value of \$.10 per share.

ARTICLE V. TERMS OF EXISTENCE

This Corporation shall have perpetual existence, commencing upon the filing of these Articles.

ARTICLE VI. REGISTERED AGENT AND INITIAL REGISTERED OFFICE

The name of the initial Directors of this Corporation are Douglas A. Peebles and Brenden S. Moriarty

ARTICLE X. OFFICERS

The executive officers of this corporation shall be a President, a Vice President, a Secretary, and a Treasurer. Any person may hold one, two, or more offices. The corporation may also have such other officers and agents as may be deemed necessary and all such officers and agents shall be chosen in such manner, hold their offices for such terms, and have such powers and duties as may be prescribed by the by-laws or determined by resolution of the Board of Directors not inconsistent with the by-laws.

ARTICLE XI. AMENDMENT

This Corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter prescribed by law, and all rights and powers conferred herein upon stockholders, directors and officers are subject to this reserve power.
