The undersigned Incorporator, for the purpose of forming a profit Corporation pursuant to Florida Statutes, Chapter 621, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the Corporation shall be PEEBLES & MORIARTY, P.A.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be:
1111 - 3rd Avenue West, Suite 210, Bradenton, Florida 34205.

ARTICLE III. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted and carried on by the Corporation is to engage in the practice of the legal profession and any lawful act and activity or business permitted under the laws of the United States and the State of Florida. This corporation is organized for the following purposes:

ARTICLE IV. SHARES

The number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1000, with a par value of \$.10 per share.

This Corporation shall have perpetual existence, commencing upon the filing of these Articles.

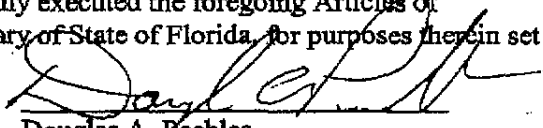
ARTICLE XI. AMENDMENT
