

# ARTICLES OF INCORPORATION of SHURSOURCE MARKETING, INC.



# ARTICLE I. - NAME

The name of this corporation is SHURSOURCE MARKETING, INC.

## ARTICLE II. - DURATION

This corporation shall have perpetual existence, commencing on February 3, 2004.


