**ARTICLES OF INCORPORATION OF


ARTICLE SEVEN

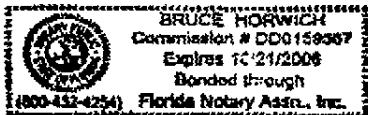
