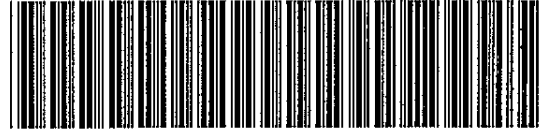

ARTICLES OF INCORPORATION

OF

WALKER FENCE COMPANY OF NEW SMYRNA BEACH

ARTICLE I **CORPORATE NAME, PRINCIPAL OFFICE** **AND MAILING ADDRESS**

The name of this Corporation shall be: **WALKER FENCE COMPANY OF NEW SMYRNA BEACH**, with its principal office located at 2819 Pioneer Trail, New Smyrna Beach, Florida 32168 and its corporate mailing address being the same.




