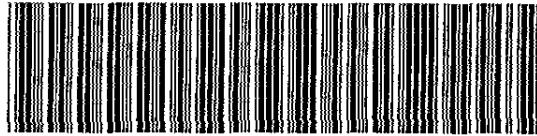

I, the undersigned Incorporator, do hereby form a Corporation under the laws of the State of Florida.

The principal office of this Corporation shall be located at 900 Sixth Avenue South, Suite 203, Naples, Florida 34102.

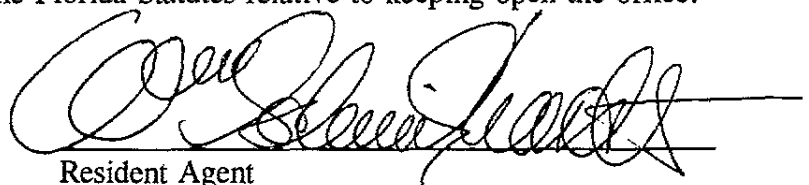
