The name of this corporation is VAN DOW CORPORATION.

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the Laws of the United States and Florida, including but not limited to ownership of real estate and all lawful activities incidental and relating thereto.

ARTICLE IV - CAPITAL STOCK


