The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the Corporation is PharmaSmart, Inc. Principal place of business is 1480 SW 96th Terrace, Davie, FL 33324.
