

ARTICLES OF INCORPORATION OF

HOMEWORKS BY GAIL, INC.

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be HOMEWORKS BY GAIL, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - INITIAL PRINCIPAL OFFICE

The initial principal office of the Corporation shall be located at 740 N. Belfast Place, Chuluota, Schilder County, Florida 32766.
