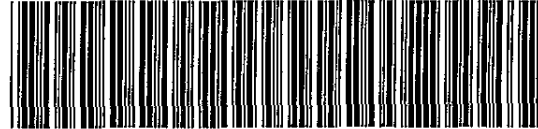

I, CHARLES S. MEYER, being of legal age do hereby authorize the formation of
a corporation under the laws of the State of Florida.

ARTICLE I.

The name of this corporation shall be CHUCK MEYER CONSTRUCTION, INC.

This corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE III.
