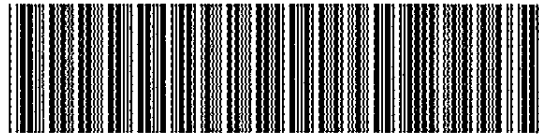

**ARTICLES OF INCORPORATION OF  
CHRISTOPHER D. FREW DRYWALL, INC.**

**ARTICLE I - NAME & PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is CHRISTOPHER D. FREW DRYWALL, INC. and its principal place of business shall be located at 22708 HIDDEN WATERS DRIVE WEST, GREEN COVE SPRINGS, FLORIDA 32043.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of installing residential and commercial drywall and for transacting any or all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue ONE-THOUSAND (1,000) shares of common stock at ONE DOLLAR (\$1.00) par value, which shall be designated as "Common Shares."

**ARTICLE V - PRE-EMPTIVE RIGHTS**

**ARTICLE VII - DIRECTORS**
