

Articles of Incorporation of Avto-Bel Corporation

Article 1

The name of this corporation is Avto-Bel Corporation

Article 2

The corporation may engage in any and all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes. While pursuing its purposes, the corporation may exercise the powers granted now or in the future by Section 607.0302, Florida Statutes, and by common law.

Article 3

The aggregate number of shares which the Corporation shall have the authority to issue shall be 20,000,000 shares of common stock, each having a par value of \$.001, and 1,000,000 shares of Class "A" stock, each having a par value of \$.001.

Article 4
