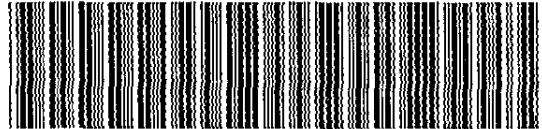

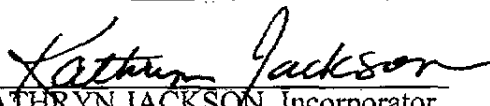
ARTICLES OF INCORPORATION

The undersigned hereby form a corporation-for-profit under the Florida General Corporation Act by adopting the following Articles of Incorporation:

1. Name. The name of this corporation is R. C. Floor Coverings, Inc.
2. Nature, Purpose and Powers. The corporation shall have perpetual existence, commencing the date these Articles are executed and acknowledged and will have the power to engage in any lawful business and have all powers enumerated in the Florida General Corporation Act.
3. Capital Stock. The corporation is authorized to issue 1,000 shares of \$.10 par value common stock.
4. Initial Registered Agent and Office. The name and address of the initial registered agent and office of this corporation is: Kathryn Jackson, 1220 E. Park Avenue, Tallahassee FL 32301.
5. Initial Board of Directors. This corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time by the Bylaws but shall never be less than one. The names and the addresses of the initial directors are: H. 7. Indemnification. The corporation will indemnify any officer or director, or any former officer or director, pursuant to Section 607.014 of the Florida Statutes, as amended.

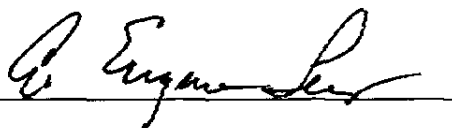

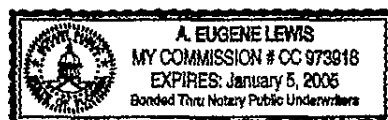

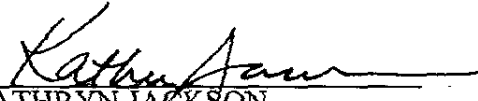
