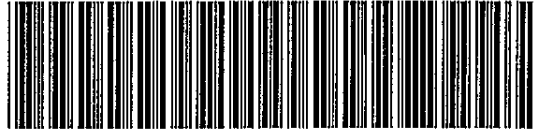

ARTICLE I
NAME

The name of the Corporation is: SANDOVAL & SONS, INC., a domestic corporation, which is not a member of any affiliated group.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 7736 Gibsonton Drive, Gibsonton, Florida 33534.

The principal mailing address of this corporation shall be: 7736 Gibsonton Drive, Gibsonton, Florida 33534.

ARTICLE III
PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of trucking and hauling; and




