

ARTICLES OF INCORPORATION OF PRIMAROPA COIN LAUNDRY, INC.

The undersigned in order to form a Corporation for the purposes hereinafter stated, by and under the provisions of Statutes of the State of Florida, does hereby subscribe to these Articles of Incorporation.

ARTICLE I - NAME

The name of this Corporation is: PRIMAROPA COIN LAUNERY

ARTICLE II - DURATION

This Corporation shall have perpetual existence, commencing on date of execution of these Articles of Incorporation

ARTICLE III - PURPOSES

This Corporation is organized for the following purposes:

- To engage in any or all lawful activity, agent, broker and any other lawful capacity.
- To purchase, receive, lease, or otherwise, own, hold, improve, use and otherwise deal with real or personal property or any b: legal or equitable interest in property wherever located; to sell, convey, mortgage, pledge, create a security interest in, lease, exchange, and otherwise dispose of all or any part of its property.
- In the purchase or acquisition of property, business rights or c: franchises, or for additional working capital, or for any other objective in or about its business affairs and without limit as to amount: to incur debts and to arise, borrow and secure the payment of money in any lawful manner. The Corporation may issue its stock for any lawful purposes, including the acquisition of any other entity.
- To engage in any or all lawful activity and to institute and d: promote commercial, mercantile, financial and industrial enterprises, and for the purposes of transacting any or all lawful business.

ARTICLE IV - POWERS

This Corporation shall have all of the corporate powers enumerated in the Florida Business Corporation Act.

ARTICLE V - CAPITAL STOCK

This Corporation is authorized to issue 1000 shares of \$1.00. EACH PAR VALUE, common stock, which shall be designated "COMMON SHARES".

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind of that which he/she already holds, shall have the right to purchase his/her pro rata share thereof, as nearly as may be done without issuance of fractional shares, at the price which it is offered to other.
