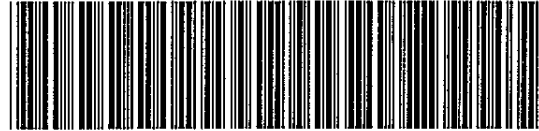



In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is All American Kwik Kerb, Inc.

ARTICLE II

The street address of the principal office of the Corporation is 16 S.E. Chinica Drive, Summerfield, Florida 34491.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 100, par value \$.01 per share, all of which shall be Common Shares.

ARTICLE IV




The Corporation shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.
