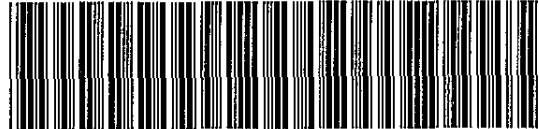



The officers of the first Board of Directors shall hold office until the first annual meeting of the Stockholders of the corporation.


ARTICLE VII: AMENDMENTS



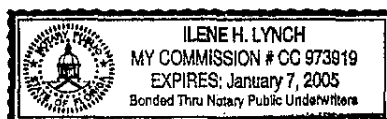
