The Company shall initially have one director. This director shall be William A. Blough, who resides at 3520 Seaford Lane, Casselberry, FL 32707.


**ARTICLE VI - INITIAL REGISTERED AGENT**

The registered agent for the Company shall be William A. Blough, who resides at 3520 Seaford Lane, Casselberry, FL 32707.


**ARTICLE VII - INCORPORATOR**
