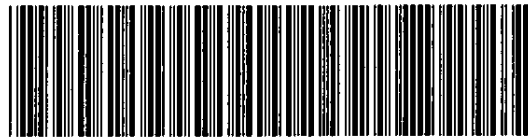


2. The name of the corporation is Blount Street Management, Inc. It is a Florida corporation.
