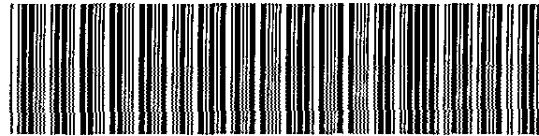




ARTICLE X - BY-LAWS




