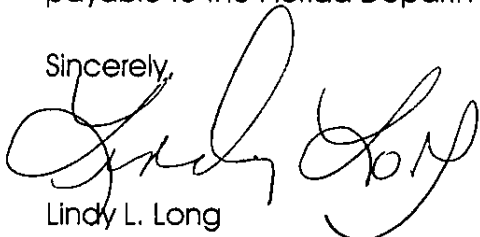

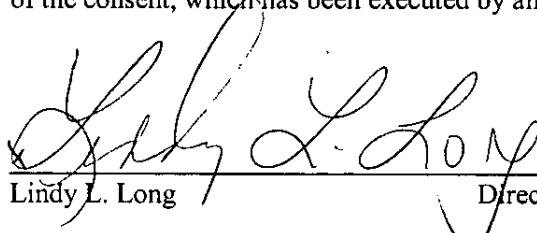

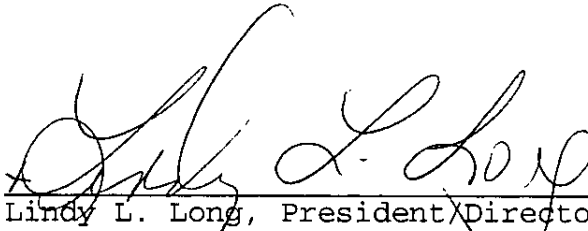
The meeting was called to order by the Chairman, Lindy L. Long. A quorum was in attendance at the meeting. After discussion, upon motion duly made, it was
