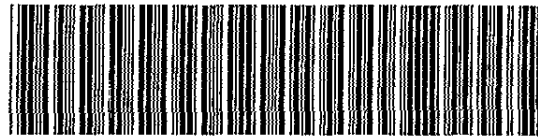



Article I
Identification




