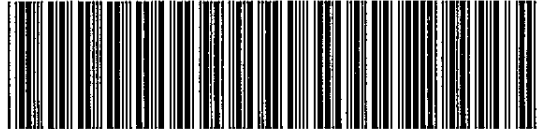

ARTICLE I - NAME

The name of this corporation is Saxenmeyer Welding Service, Inc.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of activities involving mechanical services.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is 100. Such shares shall be of a single class, and shall have a par value \$ 1.00 per share.

ARTICLE IX - AMENDMENT




