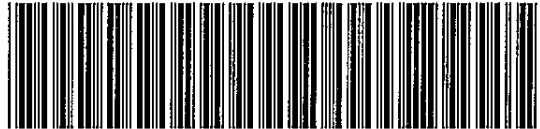

ARTICLES OF INCORPORATION
OF
ROBERT M. HUFFMAN, INCORPORATED

I, ROBERT M. HUFFMAN, do hereby incorporate myself for purpose of becoming a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is: ROBERT M. HUFFMAN, INCORPORATED.

ARTICLE II

The corporation will have perpetual existence.

ARTICLE III

This corporation is organized to provide services for compensation in connection with the solicitation, promotion, and coordination of the sale, exchange, lease, or purchase of residential realty, including assisting or directing the procuring of prospects or the negotiating or closing of residential realty transactions calculated to result in the sale, exchange, or leasing thereof. The corporation may also provide other related services not prohibited by law.

ARTICLE IV

The aggregate number of shares of stock which this corporation may issue is One Million (1,000,000), all of which shall be common shares with a par value of One Dollar (\$1.00) per share. Each shareholder has full preemptive rights to purchase shares held or owned by other shareholders of the corporation. Each shareholder of any class of stock of this corporation is also entitled to full preemptive rights to

Each shareholder of any class of stock of this corporation has full preemptive rights to purchase corporate securities carrying rights of subscription to, and/or acquisition of, any unissued or treasury stock.

ARTICLE V

The business affairs of the corporation shall be managed by the shareholders.

ARTICLE VI
