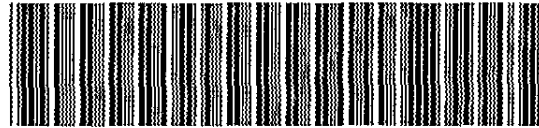

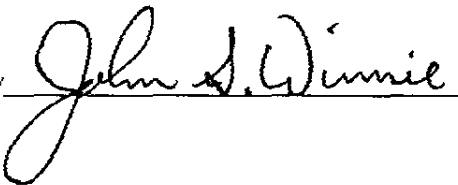

ARTICLE IV

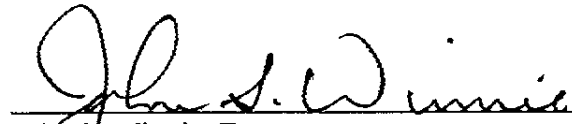

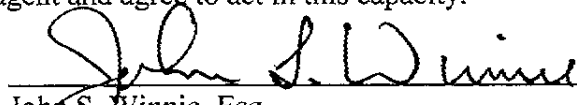
