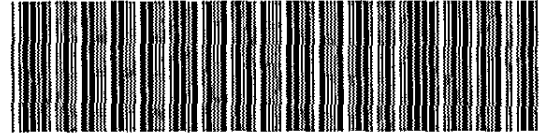



1. Article I - Name: The name of the Corporation shall be EXTERIOR COATINGS OF NORTH FLORIDA, INC.


