#### ARTICLES OF INCORPORATION

#### <u>OF</u>

#### K. B. DECOR, INC.

The undersigned subscriber is a natural person competent to contract and hereby form a corporation for profit under Chapter 607 of the Florida Statutes.

#### **ARTICLE 1 - NAME**

The name of the corporation is K. B. Decor, Inc.

#### ARTICLE 2 - TERM OF EXISTENCE

The corporation shall have perpetual existence.

#### ARTICLE 3 - PURPOSE OF CORPORATION

The corporation shall engage in any activity or business permitted under the laws of the United States and the State of Florida.

#### <u>ARTICLE 4 - PRINCIPAL OFFICE</u>

#### ARTICLE 5 - CORPORATE CAPITALIZATION
