# ARTICLES OF INCORPORATION

#### OF

The undersigned incorporator hereby certifies to the following in order to form a corporation for a profit under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of this corporation is JERRY GLOVER, INC.

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence.

## **ARTICLE III - PURPOSE**

The general purposes for which the Corporation is organized are the following:

may also include the corporation as a party. These restrictions are intended to preserve exemptions under federal and state securities laws, to provide for orderly changes in ownership of shares, and to serve other reasonable purposes.
